3 Provisions for execution

3.1 The parquet or wooden flooring shall be coated in accordance with configuration A or B below with the maximum wet application amounts (+10%) listed:
Configuration A

Product type		Application amount per layer [g/m²]	Name of the product
Topcoat Oil	2	30	Proff Woodcare Industrial Oil

Configuration B

Product type	Number of layer	Application amount per layer [g/m²]	Name of the product
Topcoat Oil (as primer)	1	30	Proff Woodcare Industrial Oil
Topcoat Oil	1	25	Proff Woodcare Professional Oil

3.2 The relevant manufacturer instructions, in particular with regard to drying times, shall be observed during application of the finish system. The instructions are deposited with Deutsches Institut für Bautechnik.

The relevant occupational health and safety provisions and the safety instructions for application shall be complied with.

3.3 Parquet and wooden flooring that is not coated in the factory and for which the general requirements given in Table 1 of DIN EN 14342 regarding wood species, thicknesses, densities, design and substrate are met shall also be considered to meet the requirements for the fire classification specified in Table 1 of DIN EN 14342 in accordance with DIN EN 13501-1³ if coated with the "Nowocoat Proff Woodcare Oil" finish systems on site in accordance with configuration A or B as described in Section 3.1.

Parquet and wooden flooring that is not coated in the factory (wood density \ge 300 kg/m³ and thickness \ge 9 mm) and for which the requirements set out in Table 1 of DIN EN 14342 are not met and existing parquet and wooden flooring the surface coating of which has been completely removed by grinding for renovation purposes shall be considered to meet the requirements for building materials classified *normalentflammbar* ('normally flammable') (building material class DIN 4102-B2 or class E_{fl} in accordance with DIN EN 13501-1) if coated with the "Nowocoat Proff Woodcare Oil" finish systems on site in accordance with configuration A or B as described in Section 3.1.
